**Summary Annual Report for  
PLUMBERS LOCAL UNION NO. 68 WELFARE FUND**

This is a summary of the annual report for PLUMBERS LOCAL UNION NO. 68 WELFARE FUND, EIN 90-1259351, Plan Number 501, for the period July 1, 2018 to June 30, 2019. The annual report has been filed with the Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

**Insurance Information**

The plan has (a) contract(s) with UNION LABOR LIFE INSURANCE COMPANY and UNION LABOR LIFE INSURANCE COMPANY to pay the following types of claims incurred under the terms of the plan:

The total premiums paid for the plan year ending June 30, 2019 were \$880,241.

**Basic Financial Statement**

The value of plan assets, after subtracting liabilities of the plan, was \$15,389,440 as of June 30, 2019, compared to \$16,964,800 as of July 1, 2018. During the plan year the plan experienced a change in its net assets of \$-1,575,360. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$17,603,586 which included employer contributions of \$14,116,300, employee contributions of \$2,694,741, other contributions of \$0, gain/loss of \$102,876 from the sale of assets, and earnings from investments of \$689,669.

Total plan expenses were \$19,178,946. These expenses included \$767,279 in administrative expenses and \$18,411,667 in benefits paid to participants and beneficiaries, and \$0 in other expenses.
