

**SUMMARY ANNUAL REPORT
FOR
PLUMBERS 68 VACATION BENEFITS FUND**

This is a summary of the annual report of the Plumbers 68 Vacation Benefits Fund, Employer Identification Number 90-1259351, Plan 502, a multiemployer welfare plan, for the period July 1, 2020 through June 30, 2021. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Board of Trustees of the U. A. Plumbers Local Union No. 68 Vacation Fund has committed itself to pay vacation benefit claims incurred under the terms of the Plan.

A total of 938 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

Basic Financial Statement

The value of Plan assets, after subtracting liabilities of the Plan, was \$2,906 as of June 30, 2021, compared to \$23,134 as of July 1, 2020. During the year, the Plan experienced a decrease in its net assets of \$-20,228. This decrease includes unrealized appreciation and depreciation in the value of Plan assets; that is, the difference between the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the Plan had total income of \$1,478,663, including employer contributions of \$1,470,852 and earnings from investments of \$7,811. Plan expenses were \$1,498,891. These expenses included \$28,039 in administrative expenses and \$1,470,852 in benefits paid to participants and beneficiaries.

If you request a copy of the full annual report from the Plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

Paperwork Reduction Act Statement
